Ambient Illumination Requirement

Make sure faces can be captured clearly.

Avoid direct sunlight and backlight .

The device should be at least 6.5ft away from the light, and at least 10ft away from the window or door.

Height Requirement



- The recommended installation height (H) is from 4.25ft to 4.75ft which can cover human height of 4.6ft ~ 6.3ft in the detection area. It can be adjusted according to the actual scene. The best temperature measuring distance
- ranges from 1ft to 1.3ft. The best face recognition distance ranges
- from 1.6ft to 3.2ft.
